# BRISTOL MOTOR CYLE AND LIGHT CAR CLUB LIMITED BYE LAWS AND RULES OF THE COMPANY AT 3 MAY 2022

## **DIRECTORS AND OFFICIALS:**

The Directors are the Chairman, Vice Chairman, Secretary, Treasurer, Competition Secretary, Social Secretary and not more than twelve and not less than four other members who shall constitute the Committee.

The President, 3 Vice Presidents, Webmaster, Membership Secretary, Awards Secretary, Magazine Editor, Marshal Co-ordinator, Quartermaster, Press Secretary and ASWMC Representative are not ex-officio Directors, but are eligible for election to the Committee.

#### **MEMBERSHIP**

Applications for membership must be accompanied by the relevant subscription.

Current subscriptions are:

- a. £20 for full membership
- b. £10 for associate membership. An associate member must reside at the same address as a full member.
- c. Members under the age of 18 at application for membership or renewal will have their membership free of charge.
- d. After 1st January following one complete year of membership, any member can be admitted as a life member on payment of £200.

The membership of any new member elected subsequent to 30 September in any year shall not expire until 31 December in the year following election.

Any member who has not renewed his or her annual membership by 31 March in any year will cease to be a member of the Company. Any member in arrears will be ineligible for Club competitions.

The liability of members is limited to 13p each in the event of the Company being wound up through insolvency.

# **MEETINGS**

A General Meeting will be held on the first Tuesday in December of each year for the purpose of electing Directors and Officials and agreeing any changes in the Bye Laws for the ensuing year commencing 1 January.

An Annual General meeting will be held on the first Tuesday in May of each year for the purpose of receiving and adopting the accounts of the Company for the year to 31 December previously and for the setting of subscriptions for the ensuing year commencing 1 January (1 October in the current year of new members joining on or after that date who will receive membership to 31 December in the following year).

Club Meetings will be held on the first Tuesday in each month. Members may bring guests.

Committee Meetings will be held on the first Monday following the Tuesday of the preceding Club meeting.

Special Meetings may be requested in writing by any 6 or more members. The request should state the objects of the meeting and must be signed by all the requisitionists and deposited at the Company's Registered Office. If a member wishes to raise and Special Business at a General Meeting he shall give to the Secretary at least 31 days notice in writing thereof.

## **REWARD POINTS**

These shall be awarded to each member who serves an official role at a club competition event. They shall be at the value of £1 per point each event at which they officiate a member will receive 5 points. They can be redeemed against any BMC event's entry fee, membership renewal or BMC clothing. The Chairman and/or the Committee have the right to issue extra reward points for a member's exceptional work which has been of benefit to the club. Points will expire at the end of the following year of issue e.g. points awarded on 1 April 2022 will expire on 31 December 2023. Points not redeemed by their expiry date are forfeited.
